During the year, the ILC continued to contract a number of consultants for the performance of specialist professional services and where the ILC requires independent review or evaluation. Additionally, the ILC acquired the services of a number of consultants to assist with the development of a number of sites, being the National Centre of Indigenous Excellence and the Black Theatre Building in Redfern NSW, Mossman Gorge Gateway Centre in QLD and Roelands Village in WA and to assist with due diligence of a potential large property acquisition in the Northern Territory.
